# NOT ONE ACKNOWLEDGED OR LOOKED INTO - THUS PROTECTING CORRUPTION IN OUR GOVERNMENT & OUR LAW SYSTEM !

**HOW A GOVERNMENT DEPARTMENT DELIBERATELY ACTED CORRUPTLY OVER 25 YEARS-AIDED BY COULDN'T CARE LESS+POLICE+MP'S+MINISTERS-RIGHT TO THE PM + OUR CORRUPT JUSTICE MINISTRY. ALL THIS TO DENY ME JUSTICE-RUINING MY BUSINESS/LIFE/HEALTH & INTO PENURY.**

**(All this backed up by documentary evidence + a Barristers legal opinion.)**

"Oh no not another one", I can hear you say, but this story is absolutely true and is a serious indictment of how our Establishment and so called Justice System treats the British Public- all too often-**UTTERLY CORRUPTLY** and worse. For what the justice system did to me also happens to others and is a massive stain on it, **that really needs exposing**-for it brings the whole system into disrepute and nowadays it's reputation is bad enough. It also shows that today only the rich can afford any sort of justice, as legal aid is now denied to everyone, except of course criminals and terrorists, etc. That makes it even more galling to victims like me, when you get 'Stuffed by the State', then **THEY** deny you any means to try to get justice against **THEM!** **This is not about any criminal activity by me-but about corruption in government & the justice system!**

I will be very brief as I know most newspapers today are not much interested in hearing about stuff like this especially from unknowns like me. I will break it down to a small a list of the events and unlawful actions. I WONDER IF THERE IS ANY JOURNALIST WHO HAS THE GUTS TO LOOK FURTHER INTO IT, **TAKE ON THE ESTABLISHMENT.** I COULD THEN ELABORATE & SHOW ALL MY IRREFUTABLE DOCUMENTARY EVIDENCE. THIS IS NO MADE UP FAIRY STORY....**YOU MUST KNOW I DO THIS NOT FOR MONEY BUT TO EXPOSE ALL THE CORRUPT BASTARDS WHO DO THIS ON A MONUMENTAL SCALE & GET AWAY WITH IT. I WANT TO DO BEFORE I DIE** -maybe not so far off now.

Brought up from 1947 in a working class Liverpool Council estate under the straightened circumstances of just after the War, I got to Grammar school and knew that I wanted to do good and make a good life for myself. After nearly 8 years in the Forces I embarked on a life of trying '**to make it**' by designing things, making them and selling through a number of businesses. I became a self taught marine & auto engineer. All my businesses in 6 worldwide countries made me a good but not a rich life, but I was still trying to find the one business that would make me enough to secure my retirement and give my kids an inheritance. In 1985 I thought I had at last found that business, only to cruelly have all my dreams dashed by British Establishment corruption:-

1. 1985 I start a car manufacturing business making replica sports cars. Best seller a Cobra Replica to which I give it - a Trade Mark name. My company roars ahead and rapidly expands.
2. 1988 I take on an agent to cover the Capital & the South East.
3. My company exports 100% of fully built cars to Europe/USA & even Japan in good numbers. Sold in the UK only in kit form. Features widely in all the media including TV News & Top Gear.
4. 1990 Company is reorganised with a new name and suffers badly from the then recession.
5. 1990 Chrysler unknown to me apply to register my T/M that I had not yet registered, but still had Common Law rights to.
6. 1992 Jan. I find this out and oppose Chrysler. **My agent goes behind my back to Chrysler posing as the T/M owner & proposes to sell it them for £500K!!.** Proving he was a common crook. He is then no longer my agent! This is the start of many unlawful actions carried by the IPO in the way they handled things from then on.
7. After a long & expensive battle with Chrysler I win in 1998 the rights to my T/M. However Chrysler say they will appeal to High Court-but then do nothing from 1998 to 2002. This exacerbates my trading position.

8. After many deliberate delays, they give in as they have no hope to ever prove they have a greater right to me and get registration. All this delay from 1992 meant my ex agent went on to copy my car design using the massive goodwill I had built up and sell it alongside mine, using my T/M. Obviously I lose 50-60% of all sales to him-but cannot legally stop him, as yet I do not have full registration-due to the IPO.

9. 2002 April. I finally get my registration, but my biz by now has been very badly affected.

10. 2002 The IPO let my agent apply to also register MY TRADE MARK- start of another 8 years of battles against him via the IPO, who side with him and engage in any number of unlawful acts.

11. 2004. His application is opposed by me and at a thoroughly corrupt and unlawfully officiated hearing the IPO allow him registration of my already legally registered T/M This stops me from stopping him from using it, so I suffer more sales losses. Due to unlawful goings on I complain to the IPO very strongly.

12. 2005. The IPO hold an secret meeting I am unaware of, to deal with the illegality I had complained about. One of their Hearing Officers found for me. That should have been the end of everything. Not on your life!

13. 2005 The IPO allowed ex agent to appeal this, even though he showed no legal rights to do so. Another secret meeting was held and I was denied knowledge of where and when let alone attendance. A Treasury Solicitors barrister officiated and this bogus Appeal Hearing was never any APPEAL but an unlawful meeting where this QC broke the law on 11 counts and gave unlawful legal advice to ex agent as to how he could circumvent the previous legal decision that went against him! **(2017) I now have a criminal barristers legal opinion on this pivotal action which agrees that 11 unlawful acts happened.**

14. The IPO illegally withheld from me & and my MP what went on at this bogus meeting for 15 months. Eventually told appeal had been dropped- again showing illegality. Agent followed all instructions and helped by IPO. Two hearings were held 2006 to 2009, which again were full of unlawful actions against me. I had to represent myself as could not afford legal representation

15. 2010. A final hearing was set up, where I opposed his trade mark registration and even though legally represented on borrowed money, it was another IPO set up and predictably they make sure I lose. **Saying they made a mistake in ever giving it me. YOU COULD NOT MAKE THIS UP!!**

The actions shown above all ruined my business, life & health. I suffered a massive stress heart attack in 2002 which nearly killed me. It meant I had to retire at only 61. My biz once in the top two specialist car manufacturers in the UK with just under £1M T/O in 1989, now worth zilch and my T/M taken from me. From 2002 to NOW I have made many formal complaints to and about the IPO and the Justice System. I have formally complained to no less than 13 different bodies including the IPO & Parliamentary Ombudsman. I have written to Justice Ministers/the Attorney General(Dom Grieve) Chancellor(Ken Clarke) PM-Cameron and again recently to the new Justice Minister. See Appendix for my letter & the reply from some CLERK. I include this so you can see what I am up against. All my efforts have been trashed by refusals/lies/obfuscations/false claims. It is obvious the Establishment simply do not want me to win, which is par for the course as seen again & again.

**Does your paper not agree that these kind of actions, show that we in the UK have a justice system that fails to protect its citizens from unlawful acts, especially so when they have been perpetrated by Ministers & its own civil servants incl its lawyers & Barristers. Acts that ruin ordinary people and their successful businesses and people's lives and health and then denies them the means to seek justice for that. The recent and awful rape cases shows how sick our justice system is but they were helped by their ongoing legal aid, which people in my position cannot even get. It's very galling I can assure you.**

**BUT THE POINT IS- DOES THE BRITISH PRESS GIVE A STUFF BY THESE KINDS OF STORIES OR HAVE THE WISH TO EXPOSE IT or is it a case of keeping sweet with them?**
